Membership and Meetings

The Chair of Strategic Advisory Committee (SAC) with UK LLC Management Group (MG) will jointly agree the timetable and agenda and reports.

The Chair in conjunction with the UK LLC Senior Administrator will maintain a record of proceedings and produce reports of meetings.

Meetings will be held every six months remotely or in person by agreement of the Chair and quorum membership.

The first meeting will review membership and ToR for the Committee which will then be reviewed annually or as required.

Comprising at least 8 independent members across disciplines and sectors and four nations, including 3 public contributors. The Committee will receive the quarterly reports enhanced with presentations from the Directors, on progress of UK LLC, provide comment, advise on strategic direction and engagement.
