1. Apologies for Absence
2. Minutes of the meeting of the 1 July, 2019

3. Matters Arising

4. Speed Watch Update
Sign caught someone doing 59mph on a Monday afternoon at 2pm on Hewson Road. However, the sign has been tampered with and has been turned round to face the wrong way. Need to put on Facebook to ask people not to turn it round. Will move to a new location next week. Can only be on a traffic sign post, not a lamp post. GW asked whether it would be possible to ask for a 7.5T restriction coming through West End
5. 49-51 West Parade Building Arrangements/Public Meeting
MC waiting for Cllr Murray to let him know what is happening. It has been suggested that site will have building material brought in off Rudgard Lane instead of off West Parade. Path would be removed on West Parade, parking spaces would also be lost on Rudgard Lane.
