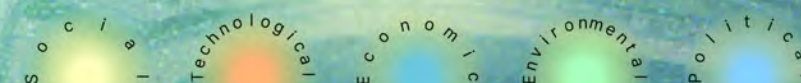

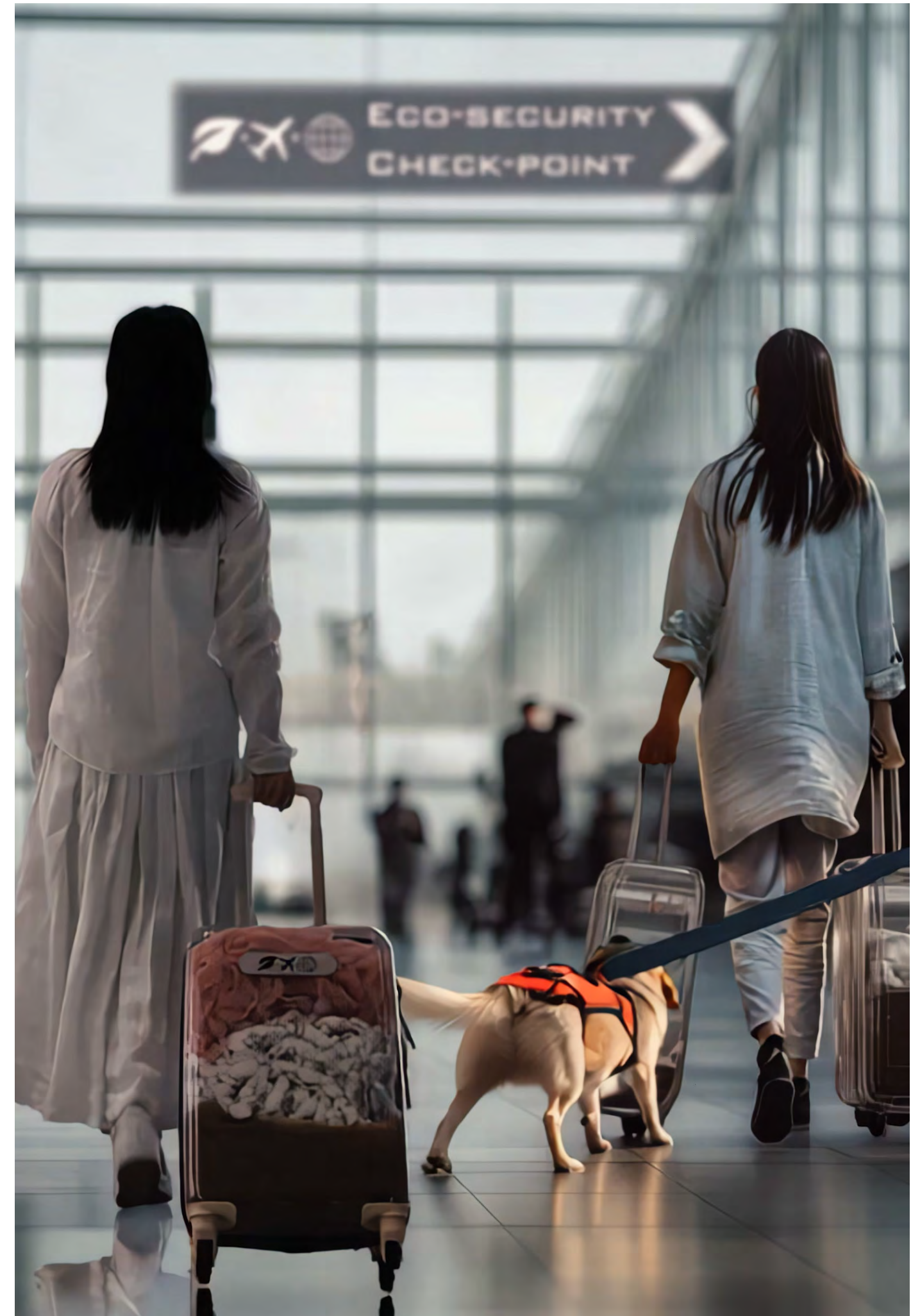
In 2040, Heathrow, governed by an unforgiving Eco-Security Policy, installation artist Sofia Liang is flagged as non-compliant and drawn into an endless bureaucratic limbo, where waiting becomes the quietest form of control. As rules shift and time unravels, she realises that compliance isn't forced—it's eroded into inevitability.

Introduction

It's **2040**, and major storms and flooding have disrupted global air travel for ten years, **revealing aviation's climate vulnerability**. Simultaneously, **extreme heatwaves caused Heathrow's first and second runways to melt and buckle**, forcing widespread cancellations in July and August. Heathrow Airport has transformed into a fully controlled **Eco-Security zone**, enforcing strict sustainability policies as a condition for travel. Two years after the completion of its **Third Runway**, the **Fourth Runway** is under construction, while the **Fifth runway** is under planning to accommodate increasing numbers of **Sustainable Aviation Fuel (SAF) flights and infrastructure**, justified by the airport's claim of achieving net-zero aviation compliance. However, SAF flights have not yet met emissions reduction targets, which is raising scrutiny from EU regulators. Under pressure to retain its status as a Net-Zero aviation leader, **Heathrow tightens its sustainability enforcement, not just on airlines, but on the travellers themselves**.

Passengers must submit **eco-compliance declarations** before landing, wear **standardised Green Boarding Outfits**, and pass inspections by **Green Nose Dogs**, trained to detect **non-compliant materials and behaviours**. Transparent luggage, **AI-driven screening**, and the **Eco-Pass system** dictate movement through the terminal. Those flagged for further review are redirected into **Holding Rooms**—silent, sterile spaces where decisions are never explained, only delayed.

Like *Playtime* (1967), the world is **coldly structured yet humorously absurd**, reducing travellers to **cogs in a seamless system**. Like *Ex Machina* (2014), **technology and policy intertwine**, quietly neutralising resistance. And like *The Terminal* (2004), Heathrow is no longer just a transit space, **it is a system of containment, where waiting becomes a form of control, and time itself wears down resistance**. And like *Severance* (2022), **subjects are conditioned into submission without knowing when the decision to comply was made**.

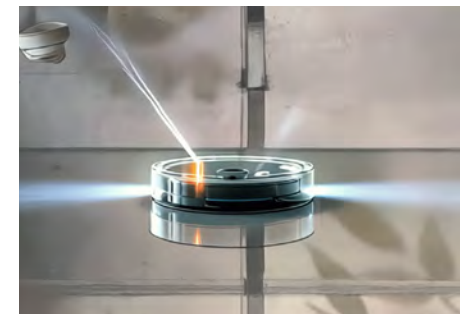

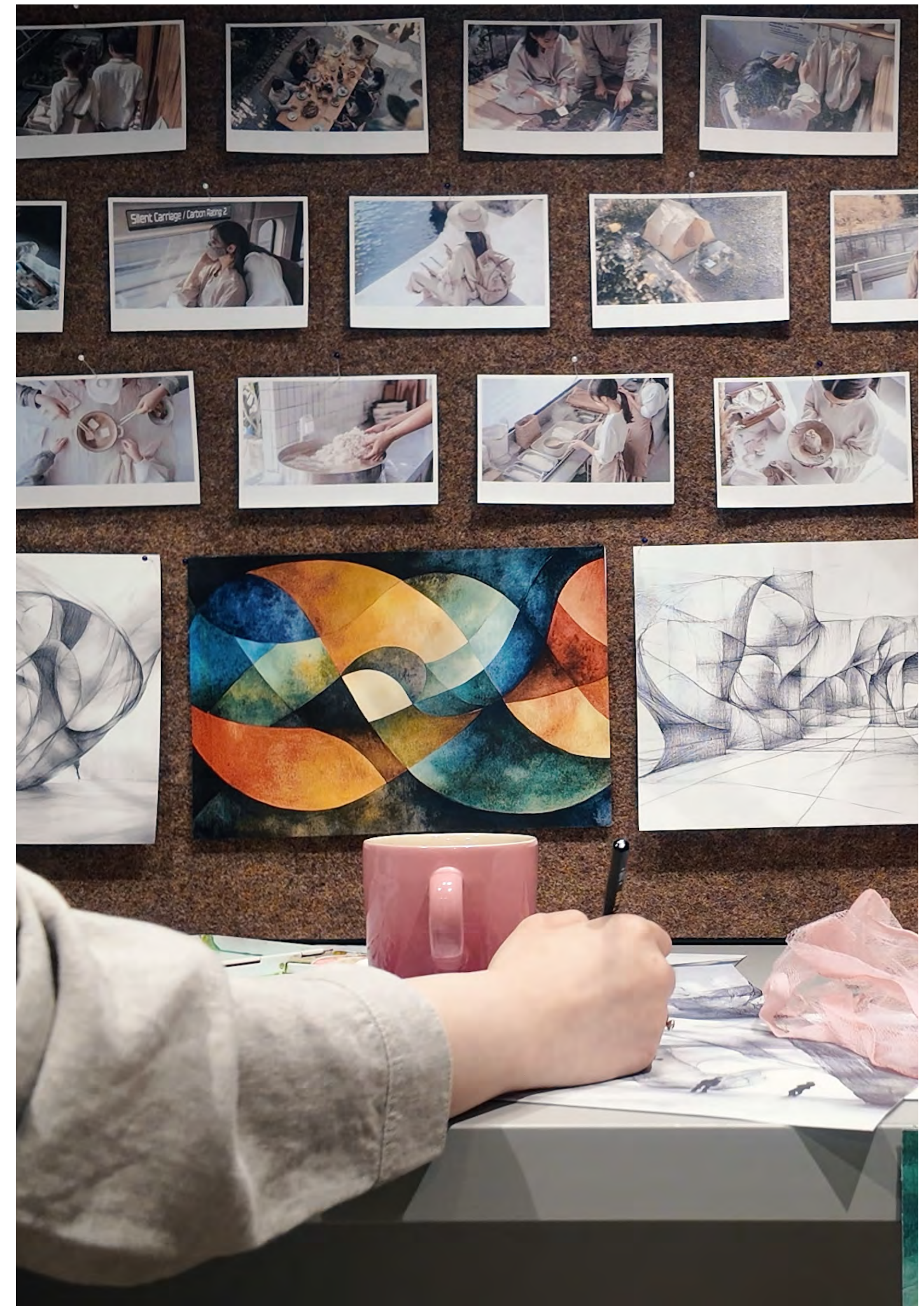


SOFIA LIANG



A celebrated installation artist navigating Heathrow's Eco-Security labyrinth

Sofia, an internationally recognised installation artist, is en route to London for a Tate Modern residency, where she will create an installation interrogating materiality, environment, and human interaction with systems of order. Her suitcase, filled with handmade pigments, found textiles, and repurposed materials, is not just her luggage—it's an extension of her practice.

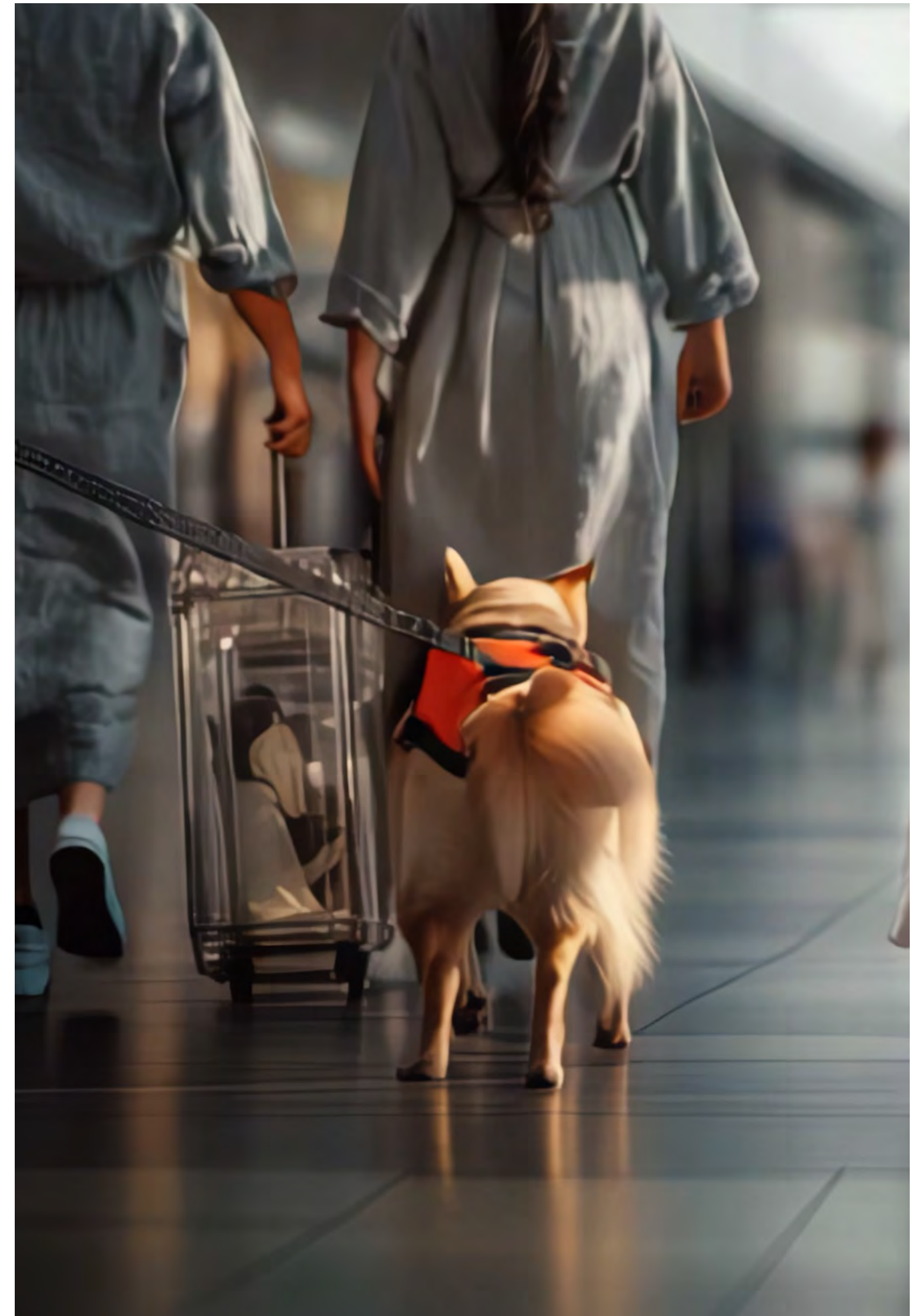


'GREEN NOSE' DOG



A silent enforcer of compliance, disguised as a sustainability measure

These highly trained detection dogs roam Heathrow's terminals, scanning passengers not for weapons or contraband but for non-compliant materials, synthetic fabrics, and traces of unapproved consumer goods.



THE WAITING ROOM FIGURES



Others were trapped in the system, their cases absurd yet entirely logical within Heathrow's eco-bureaucracy



THE MUSICIAN – A travelling cellist whose wooden instrument is flagged for “illegal deforestation.” Now stranded, he waits for clearance that may never come.

THE CHILD – A young girl clutching a stuffed teddy bear, which security deems non-compliant due to synthetic fibres. She silently exchanges it with the other young boy with a ‘non-compliant’ bunny.

THE TRAVELLER – A lady en route to visit family, who walks with the aid of a hip implant. Her body is flagged for “non-compliant materials,” and she is denied passage. Her medical necessity becomes a violation in the eyes of the system—she stands still, trapped in a system where healing is treated like harm.

Each of them is caught in a waiting game where rules shift without warning, and time becomes the ultimate tool of compliance.

ECO-SECURITY STAFF



Human face of a rigid, automated sustainability regime

Dressed uniformly in linen garments bearing the Eco-Security logo, these airport officials embody Heathrow's stringent sustainability guidelines. Polite yet impersonal, their primary role is to enforce compliance by quietly directing passengers, tagging belongings, and ensuring travellers submit smoothly to the eco-regulatory process. They are both representatives and products of the system—agents of subtle control whose presence reinforces a seamless yet unsettling efficiency.



PurifAi



A silent enforcer of purity, ensuring the waiting room remains “sustainable enough.”

These small, transparent, disc-like robots glide soundlessly across the floor, their soft red LED rings pulsing in a steady rhythm. Officially, they exist to purify the air, regulate carbon levels, and maintain a sterile environment, but their function extends beyond cleaning. Integrated with Heathrow’s behavioural tracking system, PurifAi discreetly monitors passengers’ biometrics, detecting stress, hesitation, and potential non-compliance. Those who fidget too much or pace excessively may notice PurifAi hovering just a little longer near their feet, as if calculating something unseen.

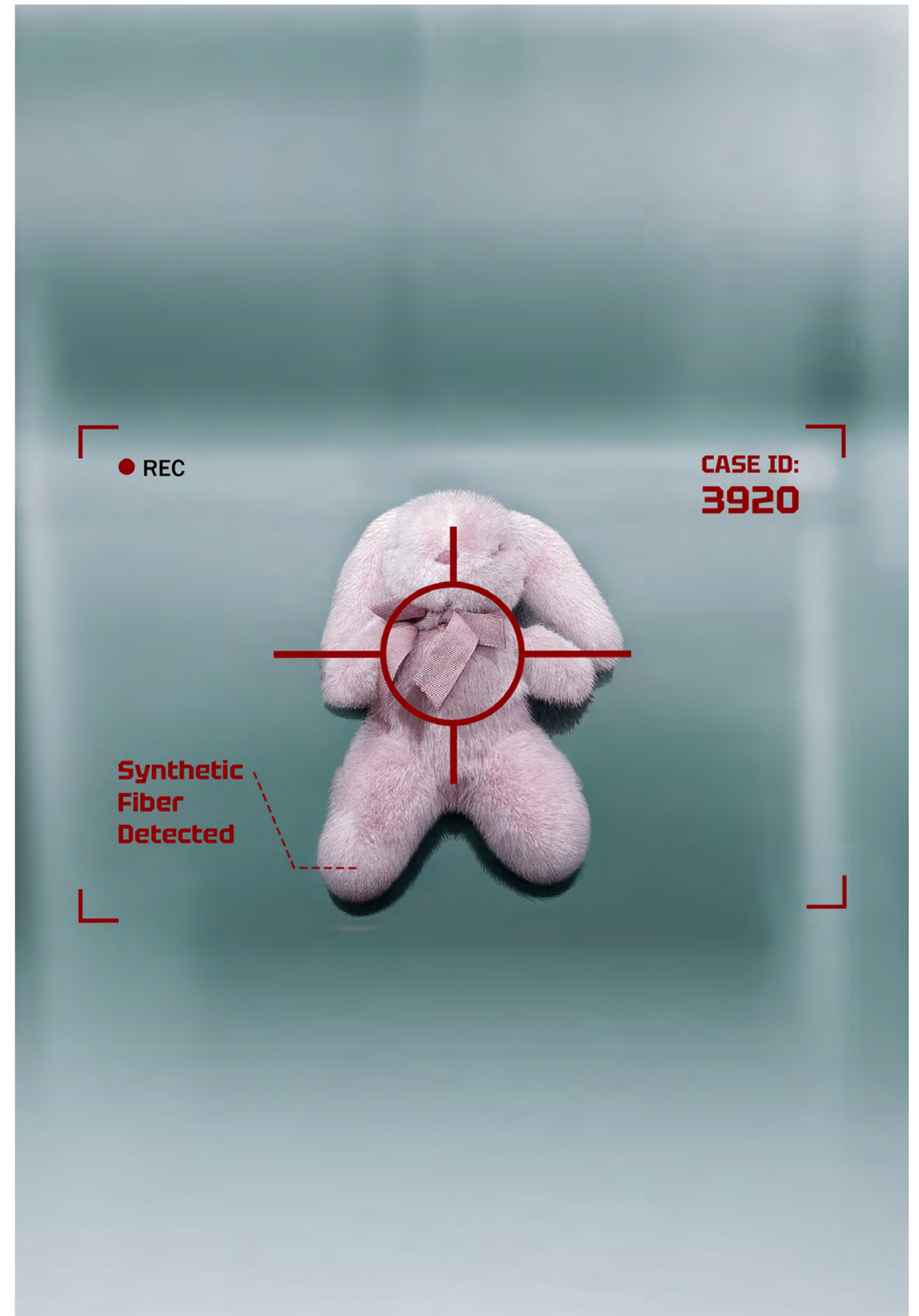


ECHO



A silent observer embedded seamlessly into Heathrow's architecture.

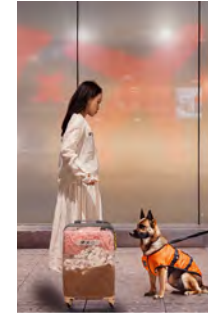
ECHO is Heathrow's integrated surveillance system, assessing passenger compliance through subtle observation of movements, behaviours, and emotional responses. Disguised as minimalist, circular sensors embedded discreetly in ceilings and corners, barely distinguishable from smoke detectors or ambient lighting fixtures, it continuously scans and analyses the environment. Without physical interaction, ECHO identifies non-compliant items, quietly marking them digitally on screens throughout the waiting area. Its nearly invisible presence creates a persistent sense of silent surveillance, reinforcing the unsettling feeling that personal autonomy is quietly but constantly observed and categorised.

Before Departure

Far from Heathrow, in a country where eco-security regulations have not yet been implemented, installation artist Sofia Liang receives an invitation from the Tate Modern. The offer is a career milestone, but also a risk—her work, centred on materiality, repurposed objects, and human interaction with systems of order, exists in a grey area under Heathrow's strict regulations.

When booking a flight, Sofia scrolls through Heathrow's Online Eco-Security Checklist, which requires travellers to check every item they intend to bring. One by one, she scans through the expanding list of restricted materials—vague references to uncertified repurposed materials, unregulated natural dyes, and ambiguous sustainability benchmarks. The descriptions are broad, leaving room for interpretation, but close enough to what she works with daily to raise concern. Are her materials explicitly banned, or would they be classified as non-compliant upon inspection?

In her studio, Sofia sits cross-legged on the floor, surrounded by materials—bundles of reclaimed textiles, crushed mineral pigments in small tins, and sketchbooks filled with drawings. She places the items one by one, uncertain whether they will pass security. The suitcase becomes a literal container, but also a symbolic threshold. It marks the boundary between home and elsewhere, between what can be carried and what must be left behind.

Despite her unease, Sofia zips up her suitcase. She walks towards the door, dressed in her "Green Boarding Outfit" and pulling her transparent suitcase behind her. The door becomes the next iteration of the frame motif, no longer digital or abstract, but physical. It is the literal threshold between her soft, private space and the system she is about to enter. She tells herself she can adapt. But deep down, she wonders:

"Guess I'll find out if my work is a non-compliant material."

Later, on the plane, the cabin crew distribute the Incoming Passenger Card. She shifts in her seat, takes the form, and holds her pen still over the first question. Each ticked box feels like signing away control, not just over her possessions, but over her right to move freely.



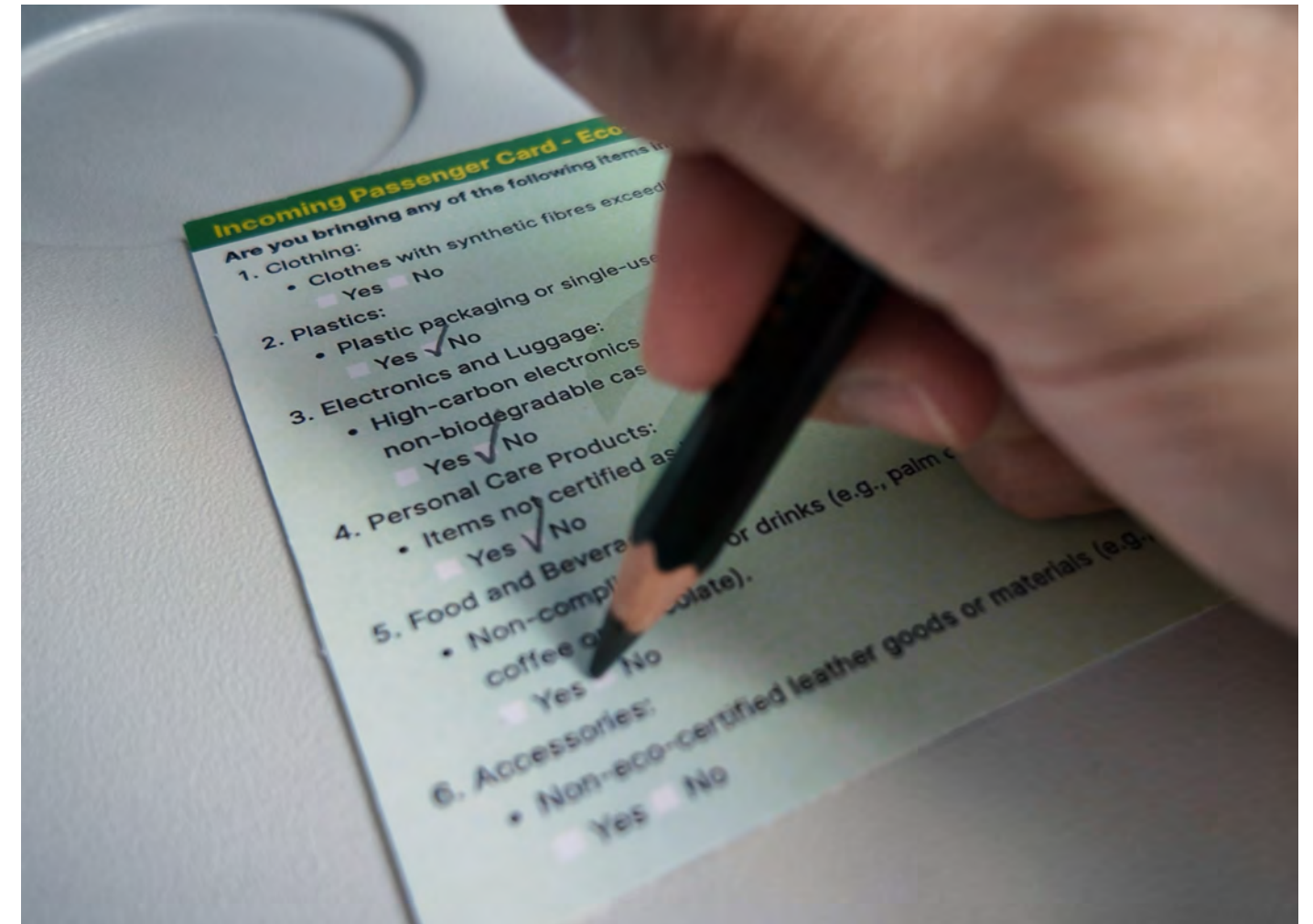
Arrival - A System of Delays

Sofia follows the flow of passengers through security, through the automated gates, through the silent approval of Heathrow's invisible authority. Then, it happens.

At security, a Green Nose Dog sits beside her suitcase, an unspoken signal. The meaning is clear — a non-compliant item has been detected. Suddenly, the ambient glow of the terminal shifts. The light turns flashing red. The Eco-Security logo behind her pulses with alarm. She remains still, suitcase in hand, as attention sharpens around her.

Without resistance or confrontation, she is quietly absorbed into the system, her movement dictated by unseen rules and silent decisions.

She is directed toward a long, descending corridor...



A long, descending corridor.

Sofia steps into the corridor, crossing from public space into controlled liminality.

The glass walls remain, and the sunlight is diffused. The natural transparency is replaced by a different kind of openness—one that feels clinical rather than liberating.

The soft hum of efficiency is replaced by silence—not heavy, not oppressive, but something emptied out, made neutral.

The corridor feels longer than it should be. A turn. Another turn. Is she going underground? Or is she simply moving deeper into the system?

The light remains fluid, but it is no longer natural—an artificial glow, designed to mimic warmth but failing to create it.

From time to time, a red light washes over the space, piercing through and briefly enveloping everything, as if trying to impose presence upon emptiness.

Behind the glass, plants grow in neat, curated displays. A promise of sustainability. A performance of nature—maintained, untouched, and utterly detached from the air she breathes.

The final doors hiss open, revealing a waiting area bathed in filtered natural light.



Inside the Holding Room

The Holding Room is not just a holding space; it is an ecosystem of delayed decisions, where passengers negotiate, comply, or resist in small, absurd, quietly devastating ways.

No one speaks loudly. No one is told what to do. But the waiting itself is the system.

This is not a place of outright defiance. Those who openly resist Heathrow's Eco-Security Policy do not reach this room. The people here are caught in the system's shifting logic, where the rules never change out loud—they change in motion.

Some are here because they hesitated. Others are here because they complied too late. A few, like Sofia, never realised they needed to comply in the first place.



Musician - Performance of Compliance

Somewhere in the corner, a cellist rests his bow against the strings of a violin—no, not a violin. A century-old cello, its wood smooth with age, the kind passed down through generations.

Suddenly, a digital notice flickers above him: Send to Isolated Room. The phrase is calm, sterile, efficient and no alarm.

In the isolated room, he places the cello between his legs as if in a final embrace. Then he begins to play.

The sound fills the waiting room, spilling into the cold air, a melody too full of life for such a lifeless space.

The sound is not stopped. It is not acknowledged.

But over time, it fades. The Musician stops. Not because he has been told to. But because his case status has been updated.

The cello is flagged for “unethical deforestation.”

The Musician claims, “It was made before the wood was even considered endangered.”

“It is now,” said the officer.

The cello is confiscated.

A staff member picks up the cello. It is wheeled out, as if it had never belonged to anyone at all.

Sofia is observing.



Sofia's Narrative & Encounter

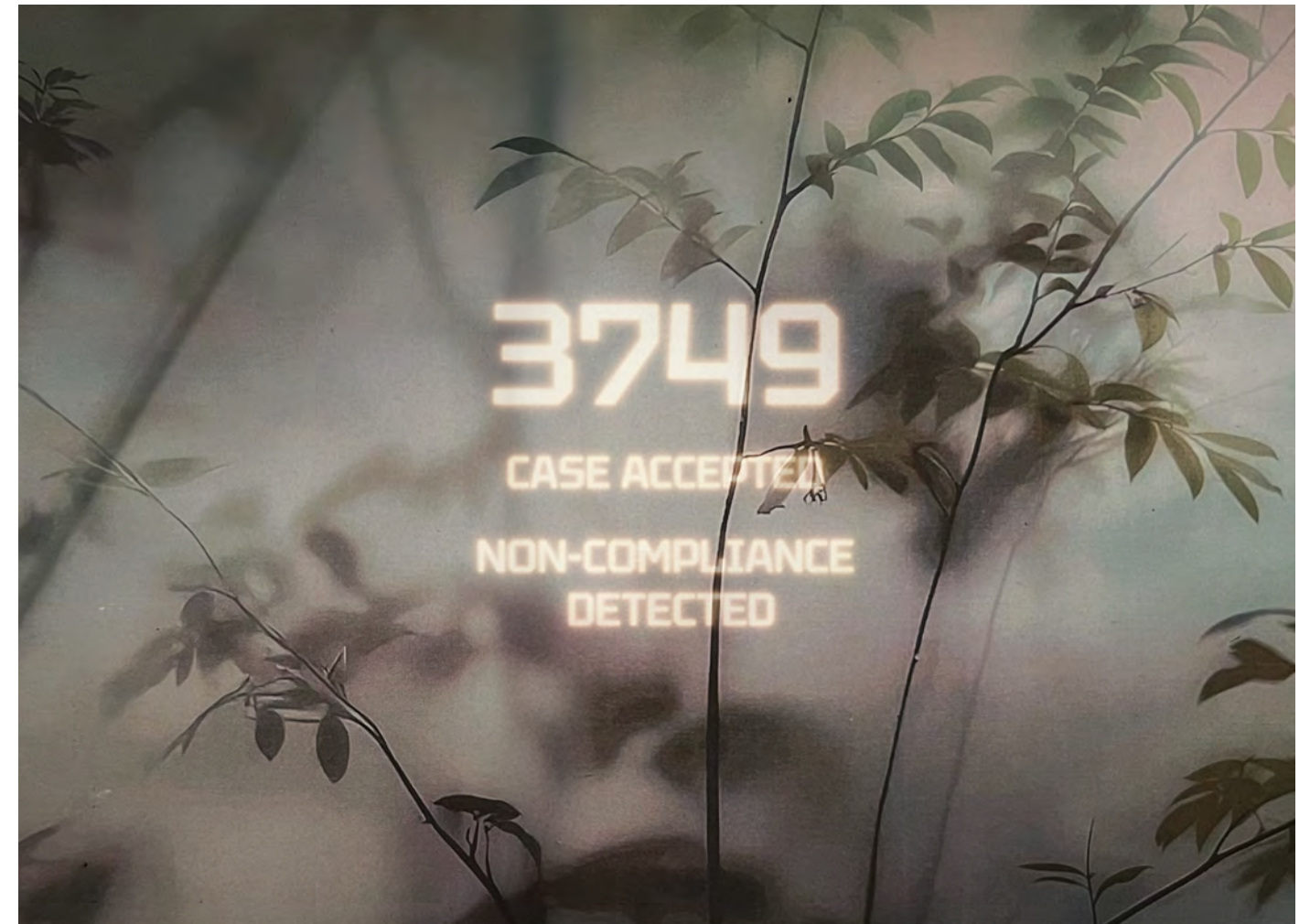
Sofia sits on a transparent chair—barely visible, barely there.

Her suitcase is by her legs, filled with textiles, pigments, and objects she brought.

She holds the suitcase's handle, tighter than she realises.
The red flicker of a passing PurifAI injects a quiet alert. Something here is not compliant.
The distant sound of the cello lingers, fragile against the sterile silence.

The mournful hum of the cello, weaving through the stagnant air.
The low mechanical hum of filtered air.
The quiet shuffle of someone adjusting their seat—a sound swallowed by the room.

A contrast of presence and erasure. She is here, but not yet absorbed.
The cello refuses to disappear, the only thing resisting the weight of stillness.



The Child - A Game of Silent Resistance

On another corner. A girl holding a stuffed toy—a small, hand-stitched bear.

She locks eyes with another child across the room, a boy gripping a small fabric bunny, something clearly loved, something equally not allowed.

The glowing ring of PurifAI sits around them like a silent referee. In this system, even innocence is subject to analysis.

With no words, no movement above the table, they slide their toys toward each other.

A perfect trade. A perfect transfer.

No rule has been broken, and yet, something is still... wrong.

Sofia is observing.



The Student - A Choice That Was Never One

A hand clutches a family photo, its warmth held against the sterile chill of the holding room.

A lady sits alone. A worn leather bag rests by her side. But the tension lies elsewhere. Something less visible, more embedded.

Above, a digital display flickers: "Non-Compliance Detected – Await Further Instructions."

She rises and steps into the scanning chamber. "Detecting in Progress" pulses in a muted white.

Then, red. It floods the space like a breath held too long.
"Item identified as non-compliant."
Her titanium implant flashes into view. Not luggage. Not clothing. But something within. Permanent.

Subtitles relay the exchange, flat and unyielding:
Staff: "I'm sorry. The titanium alloy implant is not compliant here."
Lady: "But it's part of who I am... It's permanent."
Staff: "I know. But you cannot enter the UK."

She moves down the "rejected" corridor. Red lights trace her path, a silent choreography of exclusion.

Her silhouette fades into the warm blur of an exit. No protest. No resolution. Only exit.

And somewhere nearby,
Sofia is observing.



The System Adapts, Sofia Observes.

Sofia watches, observes, and draws.

Her pencil moves quietly, deliberately.
She begins to sketch what she once drew at home—an installation
taking shape again, line by line, across the paper balanced on her
suitcase.

It's the same piece, yet not the same.
Here, under fluorescent light and silent surveillance, the drawing
becomes more than a plan.
It becomes a thread—a quiet continuity between who she was and
where she now waits.

Around her, belongings are inspected, decisions handed down.
But Sofia draws.
Not as escape, not as defiance, but as a way to remain whole.

Each mark traces more than form—it marks time.
A soft unfolding between announcements, between outcomes.
While others are judged and processed, she sketches what cannot be
seized.

It's not a product.
It's presence.
A reclaiming of authorship in a space that asks for surrender.

She is not mapping the room.
She is making something through it.
And in doing so, she does not disappear.



Why Are They Here? The Bureaucratic Loop

The waiting room is not for those who refuse outright.

It is for those caught in the system's quiet, shifting mechanisms:

- Some hesitated too long.
- Some followed the rules, but not quickly enough.
- Some never even knew they had to comply.

This room exists between categories—between approval and denial, between compliance and resistance.

The Green Nose Dog is the first judge. The waiting room is the final one.

Some will leave. Some will not.

All will adapt.

And Heathrow, as always, remains in perfect order.



Sofia's Ending: A Border That No Longer Exists

Sofia waits.
She waits through the Musician's song, through the Lady's sighs,
through the Child falling asleep.

She waits.
And then, at last, her case number flickers onto the screen.

"Case 3749: Cleared"

She rises. No dialogue. No acknowledgement. Just the quiet signal of permission.

The doors part soundlessly. A corridor unfolds before her, identical to the one she came from, but reversed. It glows with a sterile green, a colour more clinical than natural. The green of Greenlight is not a welcome, but a verdict. She is permitted to proceed, because what is left of her fits the requirements.

In her hand is the suitcase.
Empty, but compliant.

As she walks, the cold light softens into a warmer tone, artificial but intentional. The distant hum of Heathrow's orchestrated sustainability wraps around her again, rehearsed and seamless.

She enters the terminal.
Still, silent.

A conveyor belt awaits. She steps onto it.

Her body moves forward, but not by choice. The walls speak on her behalf now:
"Heathrow Leads the Future of Sustainable Travel."

She is framed by symmetry, reflections echoing around her. Centred, but passive. Present, but not quite there.

She holds the suitcase close.
And steps forward.



“Welcome” to London

Sofia steps into the open space outside the terminal, suitcase in hand. The space is expansive, clean, and quiet — the kind of grand terminal architecture meant to impress and contain.

In a gust of wind, she stops.
She looks at her suitcase.
It is empty, with the bold green tag reading “APPROVED” wrapped tightly around it.
Just the bare structure, an object stripped of all its meaning.

She looks at the suitcase again. A shell of itself. A structure meant to hold something, now holding nothing.
For a brief moment, she sees it not as a loss, but as a composition.
An empty frame. A void, perfectly contained.
A space that was meant to carry, but now only reveals.

And she thinks:
“Is this not an installation already?”
She places the suitcase on the floor, steps back, observes.
And then—she walks away.

She steps into the open-air terminal, blinking against the sudden brightness. Heathrow is green, clean, efficient. A world designed for the future.
She is inside now.
She has nothing left to carry.

And Heathrow, as always, remains in perfect order.

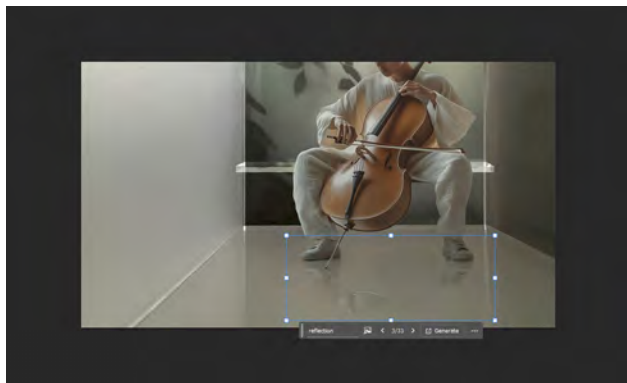
